The National Health and Medical Research Council (NHMRC) and the Water Quality Advisory Committee (WQAC) is undertaking consultation on possible approaches to **managing disinfection by-products (DBPs) in Australian drinking water supplies**. Your feedback will help inform a revision of Section 6.3.2 of the Australian Drinking Water Guidelines (ADWG), alongside a rolling review of related fact sheets and guideline values for DBPs.
