A project is under way to review the **high pressure water jetting** units of competence included in the Manufacturing Training Package (MSM) plus the potential to create to a new unit on hydro excavation. There is a consultation paper available at <https://tinyurl.com/y8jfgoxe> that outlines the project and seeks feedback from industry about the proposed changes to the units. Feedback needs to be sent to the project manager, IBSA by Friday 26 June 2020. Due to the high risk nature of operating this equipment, we strongly encourage all water utilities to read the consultation paper and provide any feedback by the closing date.

The Productivity Commission has commenced the **2020 National Water Reform Inquiry** and has released an issues paper. WIOA will be making a submission and will concentrate on issues related to skilling and operator training needs for the water industry. Initial submissions are due by Friday 21 August, with the final report anticipated in early 2021.
