AROUND THE TRAPS

At the WIOA Inc AGM held online on 21 April, **Mark Samblebe** was announced as President and George Wall continues as the Secretary/Treasurer. A total of 456 members participated in the online voting process, which saw **Sally Shepherd** elected as Vice President. Ryan McGowan, Elise O'Keeffe, Heidi Josipovic and Grant Waite were re-elected and they are joined on the Committee by Bill Collie. President Mark congratulated outgoing President Heidi for doing such an outstanding job over the past two years. He also thanked outgoing Committee members in Kathy Northcott and Simon Page for their efforts. The Chairs of the State based Advisory Committees in Alan Butler (NSW), Robran Cock (SA), Colin Haynes (Qld), Stephen Westgate (Tas) and Anthony Evans (Vic) were also confirmed and are on the Committee.

The Australian Department of Agriculture, Water and the Environment has released six new **Default Guideline Values (DGVs)** and associated technical briefs on the ANZG Water Quality website. These include Alpha-cypermethrin in freshwater; Bisphenol A in freshwater; Bisphenol A in marine water; Dioxins in freshwater; Fipronil in freshwater; and Mancozeb in freshwater. The six DGVs will be published as draft for a period of three months until 3 August 2021, at which point they will become final unless new peer-reviewed scientific or technical information justifies a re-examination. The DGVs have progressed through rigorous peer-review and technical and policy committee review processes. The **Australian Skills Quality Authority** (ASQA) has recently approved an extension to the train out period for NWP30219 Certificate III in Water Industry Operations to now end on 31 December 2021. The Water Industry Reference Committee requested ASQA to consider the extension. The request was based on evidence that COVID had disrupted training of water operators throughout 2020 and that closing access to the previous version of NWP on 31 August would genuinely disadvantage a large cohort of trainees currently undertaking training in NSW in particular.

The **National Construction Code 2022** public comment draft has been released and WIOA members are encouraged to review the changes made. In particular Volume Three, the Plumbing Code of Australia has been significantly revised. Although not related to water works or the treatment side, some areas will be of interest to members.
