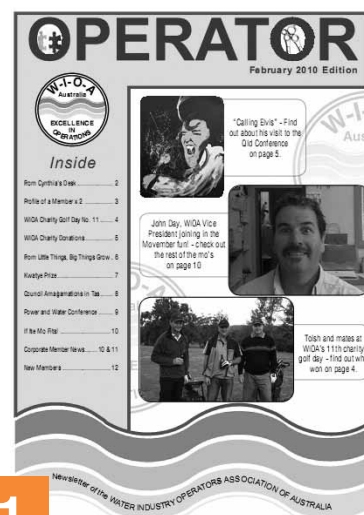

ABOUT WIOA



The Water Industry Operators Association of Australia (WIOA) has a long history of servicing its members and those employed in the “operational” side of the water industry.

Originally founded in Victoria in 1973 as the Wastewater Purification Plant Superintendent and Operators Association, the organisation has continually evolved and expanded its focus. It now covers operational issues across all sectors of the water and wastewater industry.

There are a number of fundamental ideals and values that have been passed down “through the ages” which influence all our activities. These include:

- keeping the cost of membership as low as possible so the annual fee is never seen as a deterrent to joining;
- keeping politics and Industrial Relations issues out of mainstream Association business;
- ensuring the Association provides value to ALL members; and
- keeping a strong focus at all times on members and their needs, and concentrating our efforts towards predominately operational issues.

Our services are many and varied. They include developing technical resources, conducting seminars and conferences, having input into the development and maintenance of the Water Training Package, providing information & videos to encourage more people to consider the water industry as a career of choice and a range of other operationally focussed activities and initiatives right across Australia.

We do all this in order to [share knowledge, skills and expertise amongst water industry operational staff and to provide opportunities for the professional and personal development](#) of our members.

By participating fully at Association events, operational professionals can improve their knowledge and skills, in turn allowing them to improve their own performance and that of the systems they operate or control.

From 2008, WIOA has been the driving force behind the development of minimum standards of training and experience for operators, in conjunction with an “Operator Certification” scheme. In 2011 this will become a reality in Victoria and there is an opportunity for this to be extended nationally in the future.

We’d like to extend an invitation to anyone employed in the operational side of the water industry to assist us in our quest to deliver improvements from the ground up. You can do this by becoming a member of the Association and by proactively sharing any knowledge or information with your water industry colleagues.

President's Message

The water industry landscape contains a multitude of organisations representing a wide variety of disciplines and interest groups. We are proud that the Water Industry Operators Association of Australia (WIOA) was originally established to represent the “grass roots” operational people working within the Australian water industry and almost forty years later they are still our primary interest group.

We have expanded our focus over the years from just wastewater treatment issues to now encompass everyone in the operation and maintenance of any part of the water cycle. This is from the catchment to the customers tap (including wastewater and reuse), in either the private or public sector.

With this in mind we can put actions to some of the key words used by WIOA to describe our goals as an organisation and how we hope to achieve them.

Communicate – through our Practical Guides, WaterWorks journal, Operator and Words newsletters, plus other regular publications. We also provide updates on industry and corporate developments along with regular notification of seminars, conferences and employment opportunities.

Encourage – by offering opportunities for operators to share their work, ideas and experience to all parts of the industry at conferences and seminars around the country. Also by recognising and rewarding people for their efforts through a range of awards and incentives for excellence.

Protect – by promoting the preservation of clean waterways, the protection of public health and a commitment to the protection of the environment as a result of being fully trained, certified and committed operators.

Network – by utilising conferences, seminars and our website as a tool to disseminate information and promote further education and training on a range of specific issues relating to the water industry.

Engage – not only with our members, but also on their behalf with industry specific organisations and governing bodies to ensure that everyone is kept up to date with issues and challenges that effect the operational side of the industry.



As a member of WIOA there is a vast network of information and experience at your fingertips, the most notable being the members themselves. Not all that long ago it was not common practice to share information from business to business. As a matter of fact in some areas, it was frowned upon! Hopefully this is no longer the case as we move forward and help each other wherever and whenever possible. It is no use reinventing the wheel and we can save a lot of wasted time and effort with a single phone call.

In the past year, WIOA has expanded its networks through the establishment of an advisory committee in Tasmania and also with the inaugural meeting of the RAMROC (Riverina and Murray Regional Organisation of Councils) in Deniliquin. There are plans to establish more groups around the country to ensure that as many operational people as possible can benefit. WIOA is happy to provide resources, information and support for these types of events. I would encourage you all to think about arranging a gathering of colleagues performing the same or similar roles at neighbouring corporations and/or councils.

Finally I would like to thank you all for your support and encouragement during my term as President of WIOA. It has been fantastic to meet so many people involved in all facets of the water industry from all around Australia and New Zealand.

The water industry is an exciting place to be in, so do the best you can to get the most out of it.

Executive Officer's Report

The support for WIOA and the interest in our various initiatives, events and activities has been exceptional in 2010. It is always a pleasure to recap on what we have been able to achieve with the assistance of our dedicated team of members, committee, staff and volunteers.

It may sound strange but one of our biggest and most exciting achievements in 2010 is one that doesn't officially carry our name or even our logo. We have worked proactively with the Victorian Department of Health and VicWater (representing the water businesses) for over three years in the development of the *Victorian Framework for Water Treatment Operator Competencies - Best Practice Guidelines*. The Framework was launched at the WIOA conference in Bendigo and we look forward to its implementation in Victoria in early 2011.

During 2010, we saw unprecedented growth in Membership, mainly as a result of the introduction of the "Utility Corporate Member" category. We now have 31 water businesses Australia wide that have taken advantage of this initiative and signed up their operational staff. We have also been proactive in promoting the benefits of WIOA membership more widely at a variety of industry conferences, seminars, forums and events.

At year's end, Individual Member numbers have climbed to 1,420 and when the Corporate and Utility members are added, we now total well over 1,700 members.

I recall the excitement in 2009 when we reached 1,000 members for the first time. We now look forward to reaching the 2,000 member milestone in the very near future.

As a result of changes to the Associations Incorporation Act, it became necessary to update parts of the WIOA Constitution. The Committee took the opportunity to review and make some additional amendments to the Constitution with all proposals put forward adopted at the AGM in March.

We continued to deliver a wide variety of high quality operationally focussed services and events for our members and we have plans to expand the range on offer in 2011.

Our three premier events – the conferences in New South Wales, Queensland and Victoria were extremely well supported. For the first time ever, the trade exhibitions at all three events sold out in record time with a waiting list of companies at each.



The delegate and visitor numbers in NSW and Qld were consistent with past years, with the Victorian event well in excess of previous records. All three conferences were outstanding successes in their own right and provided an ideal forum to learn about important operational issues, products and service developments.

WIOA can only offer such value for money events with the support of our very generous sponsors. In particular, we'd like to note the outstanding contribution of our Prime Sponsors in Rad-tel Systems, ITT Water & Wastewater, Acromet Australia and Peerless Industrial Systems. Along with the Prime Sponsors, we had a number of event Hosts and other companies take up sponsorship opportunities at one or more events. We greatly value the support and commitment of every company participating at a WIOA event.

Our seminar series continued in 2010 with the addition of the "Coag/Flocc" seminar which was conducted in Melbourne and Brisbane. This seminar provided the opportunity to run a dedicated product display allowing a few Corporate members the chance to showcase their wares to a targeted audience. Other seminars were held in Shepparton and Launceston, with many more on a wider range of topics planned for 2011.

Recognising the achievements of water industry operational staff is extremely important and we have been fortunate to be able to present a number of awards, some National and others State based. A couple of new awards were added in 2010 with the support of *qldwater* and we were pleased to have continued strong relationships with our other very generous award sponsors.

A listing of all the conference and award sponsors as well as the award winners appears later in this booklet. We ask all Members to keep these companies in mind and try to return the support when you purchase products or services for your workplace.

Our relationship with kindred water industry organisations has remained strong and WIOA has continued to be represented on a number of National industry working groups. Amongst a variety of forums, project and working group commitments, we have again been actively involved with Government Skills Australia (GSA) as a member of their Water Industry Advisory Committee (WIAC).

We strengthened our working relationship with the Australian Water Association (AWA) through a series of executive level discussions and attended and exhibited at a number of AWA events. We attended meetings of the Water Industry Skills Taskforce (WIST) where we presented information on issues relating to training, skills development and certification from an operational perspective. We also provided significant feedback to AWA during the development of the Business Plan for the National Water Skills Strategy. We look forward to assisting with the implementation of the Strategy options in the future.

Late in 2010, we finalised an arrangement to transfer the production and publication of our flagship technical Journal "*WaterWorks*" to the AWA. Importantly, there will be no change to the format or type of content published. As with past years, WIOA is reliant on our members to supply much of the material for the journal and to keep the production costs down and ensure that *WaterWorks* remains viable, we certainly need the advertising support of as many corporate organisations as possible.

The Memorandum of Understanding (MoU) with the Water Industry Operations Group of New Zealand (WIOG) was updated and signed for an additional three year period and a new MoU with the Qld Water Directorate (*qldwater*) was developed and signed. WIOA expanded its networks significantly and one of our 2011 goals is to further expand the networks in all States to allow even more interaction and knowledge sharing between water industry operational staff.

Our staff did a terrific job keeping members informed and produced four editions of our newsletter "*Operator*" along with a monthly instalment of our enews "*Words*". Members may have noticed how much some editions had grown as a result of people being prepared to put pen to paper and let us know what was happening. We again ask all our members to contribute to the Association by providing information that we can distribute in any of our publications. An article, letter to the editor, opinion on a particular topic, or a snippet of info would be gratefully received.

In order to get operators to communicate their great inventions or ingenious fixes to problems, Aqualift Pacific suggested we create a new award – the PASS (Problem Accepted, Solution Supplied) award. Aqualift, as prize sponsor, will cover the costs for the winner to attend the tour of NZ and the WIOG conference each year. The inaugural winner will be announced at the NSW conference in March and entry details are on the WIOA website.

Following the outstanding success of the water series of Practical Guide books, WIOA's Technical Advisor, Peter Mosse and his fantastically committed team of co-authors and reviewers recently commenced the production of a similar series covering wastewater issues. The first of four titles - the Practical Guide to the Management of Odours in Sewage Transport Networks is due for release in early 2011 with the remaining books planned for progressive release from mid 2011.

The 2011 year is already shaping up to be an exciting time for WIOA and we look forward to delivering even more for our members and the water industry.

Summary of WIOA Financial Position

From January 2010, all financial information has been recorded using the MYOB accounting program. This change has streamlined the accounting function but makes it impossible to produce reports exactly in the previous categories, hence the differences between 2009 & 2010 in the summary table.

The consolidated financial report above is a summary only and has not been subject to a full audit. A copy of the audited accounts for WIOA Inc & WIOA Ltd will be available from the WIOA website in March 2011. Members requiring a full copy of the reports prior to the AGM can contact the WIOA office.

Income from all sources in 2010 (excluding GST) has remained consistent with previous years, as has expenditure. When the pre-payments associated with the 2011 NSW conference trade exhibition are taken into account, an overall net surplus from operational activities of \$12,238 has been achieved in 2010. This result is in line with projections approved at the start of the year to run a balanced budget.

During 2010 WIOA undertook a strategic review of its risk profile from an operational and financial perspective. The review highlighted the reliance on conferences and events as the major source of operating income and that insurance premiums were prohibitively expensive to cover all possible loss scenarios as a result of natural events such as the recent flooding along the East coast. The Board has determined that WIOA will increase cash reserves commensurate with the growth of the organisation and an annual review of the perceived risk profile. This will ensure that WIOA can continue to deliver the annual program of seminars, trade exhibitions and conferences at an affordable cost to all.

WIOA is committed to the continuation of the Operators conference in NSW, Qld and Victoria and the one day seminar series was expanded in 2010. The range of seminar topics and the location of events will be broadened again in 2011.







In summary, the Association is in a strong financial position and has adequate funds to continue to provide member services at existing levels. This sound financial position will enable WIOA to develop and subsidise an expanded range of operator focussed events and services throughout 2011.

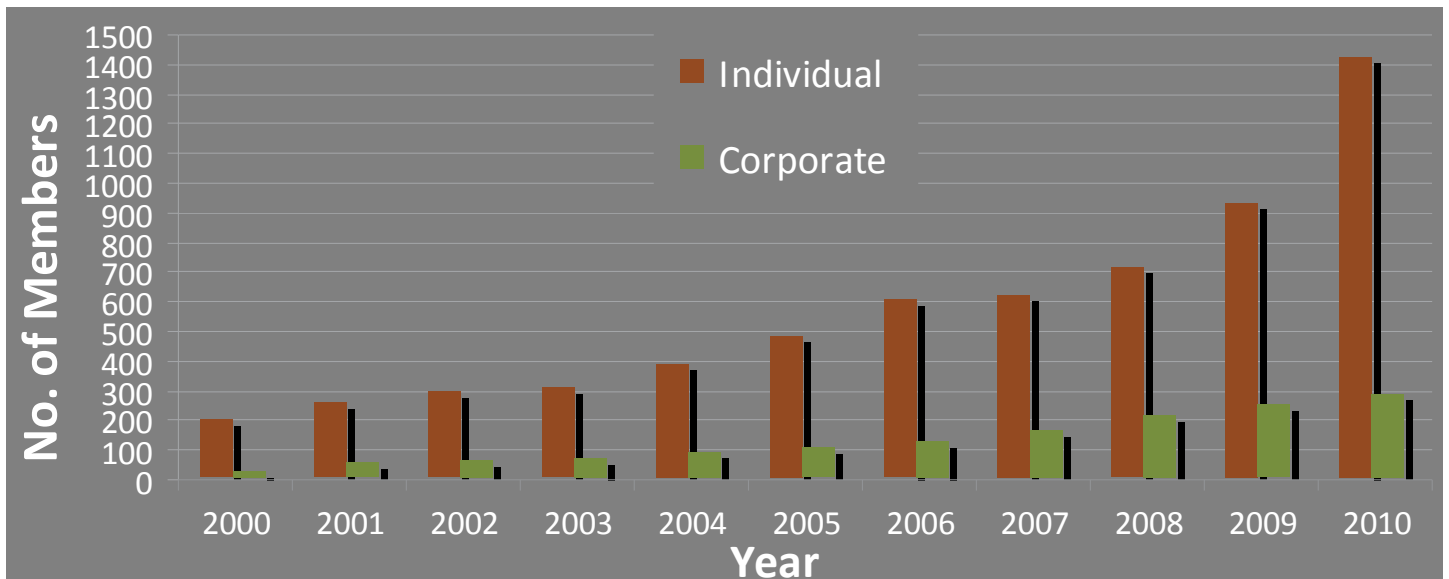
Membership Statistics & Distribution

Membership Statistics



In 2010, a total of 615 new Individual Members joined the Association. There were 33 Member resignations attributed to retirements, changes in employment or other reasons. Unfortunately, there were 88 Members whose names were removed from the database after February due to non-payment of fees. The effect of this was that Individual Member numbers increased by 494, taking the total to 1,419 at years end.

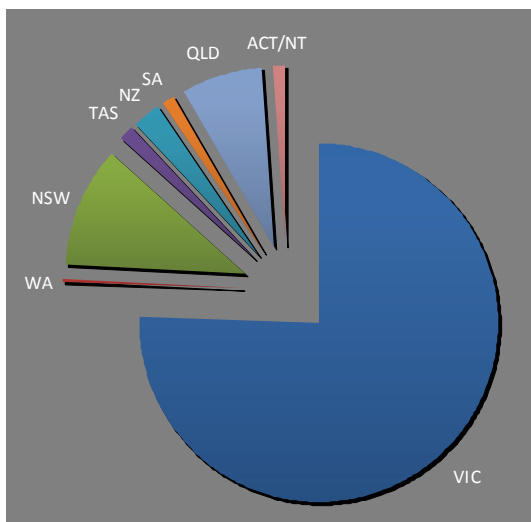
There was strong growth in the Corporate and Utility Corporate Member categories with numbers increasing from 249 to 286.



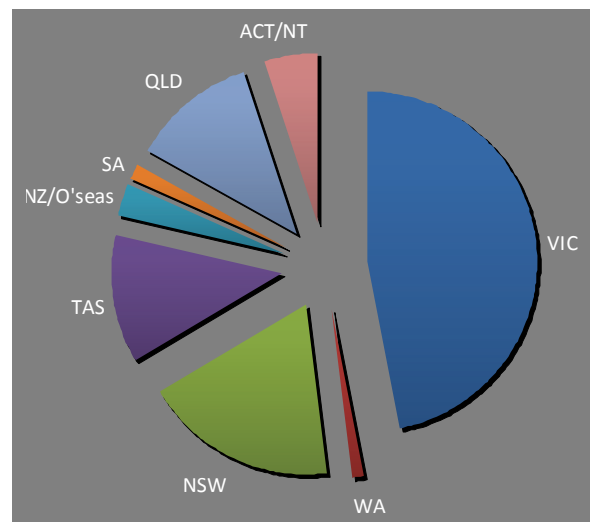
Membership Distribution

Membership Distribution 2010

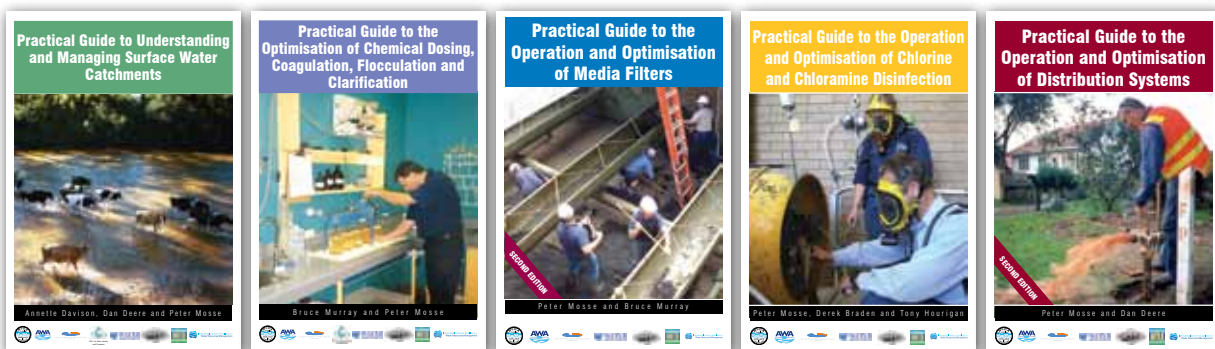

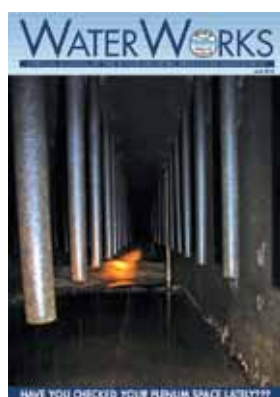


Work is under way on a series of Practical Guides to Wastewater Treatment for release in 2011.

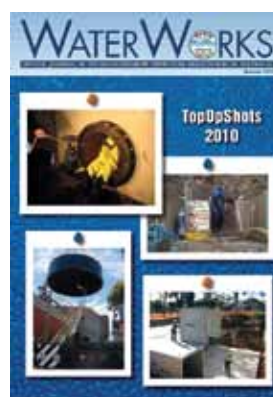
WaterWorks – Technical Journal

Operator Certification

WIOA has worked proactively with the Victorian Department of Health and VicWater (representing the water businesses) for over three years in the development of the “*Victorian Framework for Water Treatment Operator Competencies - Best Practice Guidelines*”. The Framework was launched at the WIOA conference in Bendigo in September and will be implemented in Victoria in early 2011.

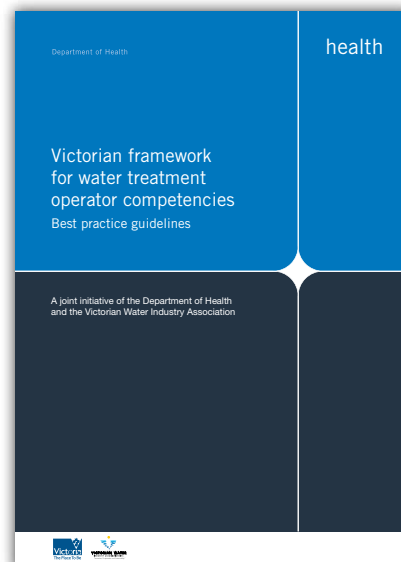
The Forward to the “Victorian Framework for Water Treatment Operator Competencies – Best Practice Guidelines” contains the following words recognising the importance of Operators.....

“On a day-to-day basis, it is the water treatment operator who carries the responsibility for ensuring that raw water is treated to the required standard, that incidents that may compromise quality are detected and addressed, and that identified risks are adequately managed. The actions taken or not taken, by a water treatment operator can have a direct impact on the health and wellbeing of the communities for which they undertake water treatment services.....”

Once implemented, for the first time in Australia we will have specified minimum training, competency and experience requirements in place, as well as a requirement to undertake refresher training to keep skills updated. Further, operators will be “Certified” under a new scheme offered by WIOA, as having the appropriate training and experience to match the types of systems they are operating.

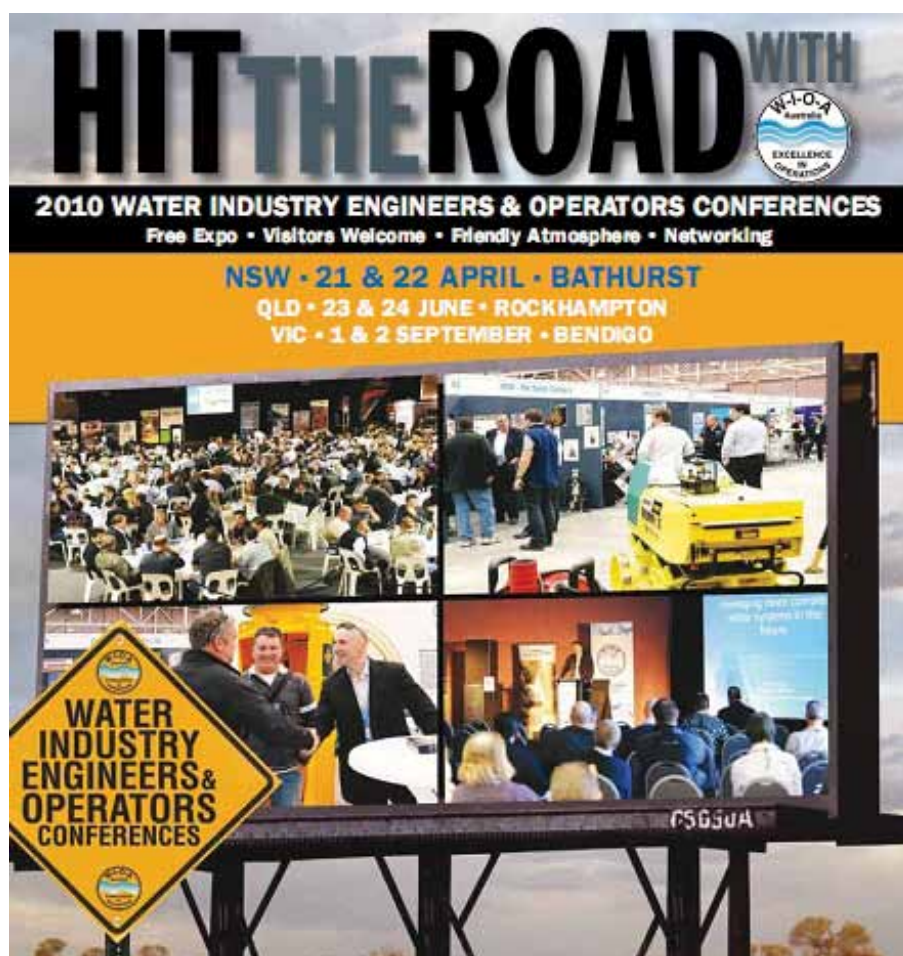
As a result of our efforts, this issue has now also gained national importance with a project to develop a National Certification Framework under way via the National Water Commission under the direction of COAG. WIOA will continue lobbying for the implementation of a similar program right across Australia, and we will also look at expanding our Certification scheme to cover wastewater and other operational disciplines throughout 2011.

FREQUENTLY ASKED QUESTIONS

How do I join, how much is membership and how can I pay?
