Chairman's Message

On behalf of the Board of WIOA Limited, I am pleased to report on our achievements in 2015. The Board undertakes a number of important functions on behalf of the Association including identifying and managing our risk profile, taking responsibility for governance of the operations of the organisation, and along with the WIOA Incorporated Committee, developing and then delivering our strategic plan.

Another important function of the Board is to ensure that the organisation is financially sustainable and that appropriate cash reserves are maintained in case of unforeseen events. In 2015, in light of dwindling interest returns from Term Deposits, we reviewed our investment strategy and portfolio. After agreeing that investing in property should be an integral part of our strategy, in October the Board approved the purchase of our own office building in Shepparton. This is an important strategic investment for the Association. Apart from immediate cash savings from not paying rent each month, the new building has ample office and storage space and will meet the needs of the organisation for the foreseeable future.

Good governance is vital for any organisation. The Board and staff have invested heavily over the last couple of years to establish and implement a proactive governance framework, including a suite of operational policies and procedures. In order to measure the effectiveness of our governance framework, the Board and WIOA Committee members recently completed an in-depth survey covering all aspects of the organisation. The survey results have allowed us to identify a number of areas for improvement in our governance, and we will work on these throughout 2016 and beyond.

Late in the year, in conjunction with the WIOA Committee, we held a workshop to review our performance for the year against the strategic plan and this was a very beneficial exercise. The shear volume of outcomes delivered is amazing and is testament to the dedication of everyone involved with the organisation. We have identified and added a number of new strategic items to ensure that we will be well positioned to proactively meet the needs of members into the future.

As always, WIOA's approach to all our operations is to provide maximum value to members and the wider water industry at the most affordable price. The financial performance for 2015 has been exceptional, given the relatively constrained state of the economy.

WIOA has a small number of very hard working staff (4.5 FTE's) who do an amazing job delivering all the services to the members annually, including organising and staging three large conferences. Being a national organisation our staff are required to travel extensively, often in their own time and they spend many nights away from home. It is appropriate to offer our sincere thanks to our dedicated staff as well as our WIOA Committee, the Directors, the members of the State based Advisory Committees and our army of volunteer members and helpers. Without them, we would not be able to run our events and provide members and the industry the wide range of quality and professionally organised services currently on offer.

Finally, the Board recently confirmed a change in title for our chief executive from Executive Officer to Managing Director to better reflect the responsibilities of the position.

Managing Directors' Review

Each year we use this introductory section of our annual review to summarise the accomplishments of the past 12 months. It is fair to say that the 2015 year was really exciting for the Water Industry Operators Association of Australia and contained a number of highlights and significant achievements.

Member numbers continued to grow in all categories and at year end, we reached a new record of 2430.

In perhaps one of WIOA's biggest and most important strategic decisions, as part of our asset and investment strategy, the Board approved the purchase of our own office building in Shepparton. Apart from the negotiations to buy the property, the task of physically moving all the furniture, equipment, stock and records was a big job. Dealing with the variety of service providers as part of the move has highlighted to our staff just how important it is to deal with member and customer enquiries promptly and efficiently.

Our organisational goals and how we intend to achieve them, fit quite nicely into 5 key categories – Communicate; Encourage; Protect; Network and Engage.

We have regularly **communicated** with our members informing them about industry news and developments using our website, social media, along with our suite of publications including Words, Operator and WaterWorks. Thank you to everyone who has contributed something for one of these publications.

Since 2001, WIOA has participated in a collaborative relationship with the Australian Water Association (AWA) to produce and distribute two editions annually of our Journal, WaterWorks. Unfortunately, AWA has changed their publications model and confirmed that they are no longer able to produce and distribute our Journal. WIOA will continue to produce WaterWorks in the future and we are currently investigating the options with publishers. We intend to advise Members of the new publication arrangements early in 2016.

Encouraging participation and recognising and rewarding the achievements of water industry operational staff is an extremely important function of the Association. WIOA offers opportunities for operators to share their work, ideas and experience with their peers at a range of conferences and seminars around the country as well as through our publications. In conjunction with a number of generous sponsors, we have again been able to present a range of Awards and incentives at a National and State level.

Details of all the conference and award sponsors, as well as the award winners appears later in this booklet. We congratulate all the winners and we know from past history that participation at our events is often the catalyst for operational staff to move on to achieving bigger and better things.

One of the primary ways we can help **protect** public safety and the environment is by ensuring that all operations staff are appropriately trained and skilled. The rollout of the WIOA Certification Scheme is progressing steadily in Victoria with 40 potable water treatment operators now certified and another 26 applications currently being processed. On the National certification scene, in conjunction with *qldwater* and the Queensland Department of Energy Water and Supply, we awarded the credentials to the first 6 operators to be certified under the National Certification Framework.

There are also a number of NSW based operators who have completed all the certification requirements and we will be holding a similar presentation ceremony at our conference in Newcastle in April 2016. Interest in certification is growing around the country and we look forward to more operators completing the all requirements to allow them to be certified.

In conjunction with *qldwater* and a number of Queensland employers, a wastewater certification scheme has been finalised. There is strong interest in this scheme not only from Queensland but also from other States. We look forward to offering the opportunity for wastewater operators to be certified in 2016 as well.

Providing appropriate and high quality services, events and development opportunities for all members remains the key focus of our Association and helps us deliver our **networking** and member **engagement** goals.

Our State based Advisory Committees are becoming more active and this inturn allows us to offer even more member engagement opportunities. The number of interest days and site tours is increasing annually and members are becoming more proactive in letting us know about issues to include, making the days even more relevant. It was also exciting to see the establishment of the South Australian Advisory Committee in 2015 and the level of enthusiasm and commitment displayed thus far makes us confident of its ongoing success.

WIOA continued to offer opportunities for our members to further develop their skills and knowledge and we delivered a number of our one day specialist seminars around the country. Being able to work corroboratively with the Victorian Department of Health and Human Services and VicWater in staging a seminar in Melbourne delivered by renowned water quality researcher, Dr Steve Hrudey was a real highlight.

Our three main events, the Operations conferences in New South Wales, Queensland and Victoria respectively, were all extremely well supported. A total of just under 2,800 people attended the three events. Support for the exhibition at each event was also strong with all three exhibitions sold out and each having a waiting list of companies hoping to participate. The range of platform and poster papers delivered made all three conferences an ideal forum to learn about important operational issues and developments in products and services.

Sponsoring partners are integral to the success of the conferences and it is important to acknowledge the outstanding contribution of 2015 Prime Sponsors in Acromet Australia, Automation Group, Ixom, Krohne Australia, Odour Pro and Xylem.

The Association was also supported by a range of other companies who took up sponsorship opportunities at one or more of our events. We greatly value the commitment of our sponsors to WIOA and we ask all Members to keep these companies in mind when you are purchasing products or services.

It was a pleasure to work with the teams from Orange City Council, Toowoomba Regional Council along with North East Water and Lower Murray Water as conference Hosts in 2015. The support and assistance of the NSW and Queensland Water Directorates and VicWater was also integral to the success of the events. WIOA again worked with sponsor Ixom to stage water taste test competitions in Tasmania, New South Wales and Victoria, with the inaugural South Australian event also held in 2015. We also worked with *aldwater* to stage a third Water of Origin competition pitting the winners from NSW and Queensland against one another at the WIOA Queensland conference. All the taste tests received excellent support, strong media coverage and are a great way to recognise the outstanding contribution that operators make in servicing their communities on a day to day basis. The State against State competition was extended even further this year with the launch of the Best tasting tap water in Australia award. We are now looking to enter the winning sample into the International competition being held in USA in February 2016.

Our relationship and collaboration with a range of other water industry organisations has remained strong and WIOA continues to actively represent our members on a number of National industry working groups and committees. With the demise of the National Water Commission and soon, Government Skills Australia, it is even more important for WIOA to pursue our advocacy role to ensure the interests of operational practitioners are considered.

As this snapshot of our activities shows, through the efforts of our dedicated staff, along with the assistance of the Committee, Directors, Advisory Committees and our valued volunteer members, helpers and supporters, we have been able to deliver much more than many people ever thought possible.

The Association is in a very solid position financially which provides us the opportunity to continue to grow the range of services and benefits we are able to offer to our members. We trust that you will enjoy reading the rest of this annual review as it contains much more detail on all our activities. Thank you to everyone who has supported WIOA in 2015 and we look forward to making 2016 another outstanding year.

Consolidated Financial Information 2015

The consolidated financial position presented here is a summary for the information of members. It has not been subject to a full audit, but fairly represents the position of the Association in relation to annual turnover and cash reserves.

The WIOA approach to all our operations is to provide maximum value to members and the water industry at the most affordable price. In determining the annual budget, the Board philosophy is to compare the projected income and expenditure streams and set prices which will provide a slightly positive (at least break-even) cash flow to the organisation by the end of the year. In 2015, a small operating trading surplus was recorded indicating the effectiveness of the budgeting process.

As part of the Association's investment strategy, and in light of falling term deposit interest rates, the Board agreed to diversify our asset portfolio by purchasing our own office building in Shepparton. Owning the office means cash normally allocated to rental payments annually will be available for use or investment.

The cash reserves held in term deposits were reduced in order to purchase the office and now amount to \$242,297. Our asset base in terms of property, plant and equipment has increased by just under \$370,000.00 for the year. A considerable amount of GST was paid to the ATO in the December quarter, mainly on the office purchase, that will not be refunded until the first quarter of 2016.

The need for adequate cash reserves is particularly important when considering how reliant the Association is on the income from our conferences and events. In these volatile financial times, cash reserves commensurate with the growth of the organisation and our risk profile are required to ensure our long term viability.

Overall, income in 2015 was 1.6% lower than 2014. Income from conferences and events reduced by 4.3%, partly as a result of holding the Queensland conferences in a slightly smaller venue but as noted in 2014, there was higher than usual payments for 2015 NSW exhibition fees and sponsorships received before the end of the 2014 year. Receiving this income in advance reduced the amount of cash received in the 2015 year. There was also a significant increase in the 2016 membership payments received by the end of 2015. Interest income was also much lower due to reduced rates.

Expenditure increased by 6.1% overall in 2015. Employment expenses increased as a result of modest pay rises for staff and from additional superannuation and workcover costs. On the property side, around \$20,000 was spent on improvements to the new office to make it functional for our purposes. There was an 8.3% increase in events expenditure with some of this due to utilising more expensive facilities than the previous year, increased delegate satchel costs, along with increased catering and refreshment costs. This was partly due to price increases but also due to higher demand with more delegates and exhibitors purchasing meals. There have also been some deposits and pre-payments made for 2016 conferences.

It should be noted that there is a staff provisions liability (Annual Leave, RDO's and Long Service Leave) of approximately \$82,000 that is not reflected in the Consolidated Financial Information.

In summary, the Association has \$100,623 in operating accounts, \$242,297 held in term deposits, and fixed assets in the form of building, plant and equipment valued at \$401,514 after depreciation.

The Association is in a strong financial position and has adequate funds to continue to provide member services at appropriate levels. This sound financial position will enable WIOA to develop and deliver an expanded range of operator focussed events and services throughout 2016.


Membership Statistics & Distribution

Through the course of the year 143 Individual and 25 Corporate members resigned as a result of retirements, changes in employment or for other reasons. Unfortunately, there were another 75 Individual Members and 13 Corporate Members who chose not to renew their membership by not paying their membership fee.

Individual membership numbers of the Association increased by 170 (8.5%) to a total of 2006 and there was also a significant increase in Utility Corporate Membership with operations staff from 10 new organisations enjoying the benefits of this category of membership. Corporate Membership has increased by 22 (6.1%) to now number 361. The ability to access membership benefits such as reduced conference exhibition fees and early notification of exhibition site sale dates have contributed to the increase. The overall result is that Association's total membership count at the end of 2015 is 2,430.

With the support of many committed members, WIOA is becoming increasingly active across Australia. The success and contribution of the Advisory Committees in Queensland, Tasmania, NSW, Victoria and South Australia has already assisted to increase the range of services, events and development opportunities for members.

During 2015, these sites received a total of 57,911 unique views, an increase in traffic 29.3%. Our presence in social media channels also increased during 2015 with WIOA communicating with members via Twitter, Facebook, Linked In and on the WIOA You Tube channel.

3 way tie in AFL Footy Tipping Competition

Members were invited to demonstrate their prowess over the AFL season by entering the inaugural WIOA footy tipping competition. Come the end of the season, it was a three way tie between Andrew Povey (Wannon Water), Manfred Glombowski (Thermo Fisher Scientific) and Shawn Charlton (Corowa Shire Council) who all selected 141 winners. Each received a WIOA prize pack and we look forward to even more members participating in 2016.

WIOA Water Industry Operator **Certification Scheme**

After launching the WIOA Water Industry Operator Certification Scheme in Victoria in December 2012, we continued working collaboratively with the Victorian Department of Health and the Victorian water businesses in its implementation.

Uptake of the Scheme in Victoria is increasing gradually and at the end of 2015, we have 40 potable water treatment operators certified and another 27 applications being processed. Many of the applications being processed are as a result of individuals needing to complete additional units of training to ensure they have statements of attainment for all processes operated.

The first group of operators certified in late 2012 have now been re-certified by tapping in to the variety of Continuing Professional Development (CPD) options WIOA has made available as part of the recertification process.

Communicating with water businesses and operators about certification has remained a high priority for WIOA. A meeting was held with operations and human resources staff from all organisations currently participating in the certification scheme. Two way communication has allowed WIOA to collaboratively develop an extremely flexible range of CPD options and has increased the level of understanding within the industry of the Scheme requirements. As a result of this meeting, the employing organisations are now able to plan out their CPD programs with greater certainty.

In 2015, the Victorian Department of Health again confirmed their ongoing support for the scheme and indicated that work to review the Best Practice Guidelines following the completion of its first three year period will be undertaken in 2016. As a result of this review, we anticipate much more interest in certification in the coming months.



National Certification

At an award ceremony held as part of the WIOA Queensland Conference in Toowoomba in June, six operators from organisations participating in the Certification Pilot were presented with their credentials. The two operators from Wujal Wujal Aboriginal Shire Council and four operators from Toowoomba Regional Council became the first operators to be Certified under the "National Certification Framework for Operators within Drinking Water Treatment Systems".

As part of the award Ceremony, presentations were made by the Queensland Department of Energy and Water Supply (DEWS), the Queensland Water Directorate and WIOA highlighting that Water Treatment Operators have one of the most important jobs of anyone in Australia, ensuring the supply of safe drinking water to our communities. In what we believe to be a fantastic milestone for the water industry nationally, by participating in the Certification Scheme, organisations are demonstrating their commitment to the adoption of best practice.

WIOA has also received written endorsement from the NSW Office of Water that any operators certified by WIOA under the National Framework will be recognised. WIOA is currently working with a number of NSW employers to finalise the requirements for their staff and a number of NSW operators will be certified against the National Framework at the WIOA NSW Conference in Newcastle in April 2016. It is pleasing to see the work started by WIOA in Victoria, now being accepted and adopted more widely.

Finally on certification, WIOA has developed a comprehensive website containing all the information necessary to allow organisations and individuals to participate in either the Victorian or National processes. We recommend everyone take the time to look over the information.

Queensland Wastewater Certification scheme development

In conjunction with a committee comprising *qldwater*, a number of Queensland employers and WIOA, a Wastewater Operator Certification Framework has recently been finalised. The content of the Water Treatment Operator Framework has been used to inform discussions and development of the necessary competency and experience requirements for the wastewater side.

There are a number of organisations now using the training V's process matrix to determine the base requirements for their staff so they can commence filling any training gaps identified. It is anticipated that some operators may be certified against the Framework in 2016.

The Framework has been shared with interested water businesses and regulatory bodies in States other than Queensland for their consideration and potential implementation. It is hoped that this will be the catalyst for more universal acceptance and adoption of the Framework.



Ixom Water Taste Tests

New South Wales Water Taste Test

The Orange City Council was announced as the winner of the Ixom 2015 NSW Water Taste Test held at the WIOA NSW Conference for the sample from their Icely Road Water Treatment Plant.

Four finalists were chosen on Tuesday evening by delegates at the welcome reception. They were the Bega Valley Shire Council (defending their 2014 title but with a different sample), Orange City Council, Port Macquarie Hastings Council and the Tamworth Regional Council.

Orange City Council operations staff confirmed that the most satisfying part about their job was knowing that Orange residents had access to clean, safe water. Just seeing the quality of water from when it comes up from the Dam to when it gets pumped out the other end to the community of Orange, it's amazing the difference in quality.

The Orange City Council sample also represented NSW in the Ixom Water of Origin Taste Test against the Richmond Shire Council, winners of the *qldwater* Best of the Best Water Taste Test and in the Ixom Australia's Best Tasting Tap Water competition.

South Australian **Water Taste Test**

The inaugural South Australian Water Taste Test was conducted in July, where 13 samples from different plants across the state were scrutinised for odour, clarity and taste. Heats were conducted where the samples were randomly divided into groups for the assembled delegates to taste. The four best tasting samples which went on to the Grand Final, as selected by the participants were; Mount Pleasant WTP, Mannum WTP, Loxton WTP and Happy Valley WTP.

An independent panel then tasted the sample from the four Grand finalists and the winner of the Best Tasting Tap Water in South Australia was awarded to the team from Allwater for the sample from the Happy Valley Water Treatment Plant. The Happy Valley facility services metropolitan Adelaide with a capacity to produce up to 850 ML/d.

Tasmanian Water Taste Test

The third staging of the Ixom Tasmanian Water Taste Test was held in Launceston in conjunction with a Water Interest Day organised by the WIOA Tasmanian Advisory Committee. Attended by almost 50 TasWater operations staff, the day included a number of technical presentations and an informative session by Olympic Gold medallist and former Australian of the Year, Shane Gould.

From the heats, the four grand finalists were chosen. Responsibility for judging the grand final samples was placed onto the guest speakers. This panel of dignitaries tasted each of the four samples and then cast their votes with the Waratah water supply coming out as the winner of the best tasting water in Tasmania, much to the delight of their operators.

The Water Taste Tests are a fun and exciting way to raise awareness of the quality of drinking water and to recognise the efforts of local water service providers in delivering valuable water services to their communities on a day to day basis. We congratulate all of the water treatment and water quality personnel who work tirelessly to ensure high quality, safe drinking water is continually supplied to the customer's tap.

Victorian Water Taste Test

Each year at the Victorian Conference, water corporations from across the state battle it out to see who produces Victoria's best tasting tap water. The Ixom Victorian Water Taste Test was again well supported in 2015 with 9 of Victoria's water businesses submitting samples for judging. The 3 grand finalists were Barwon Water, Gippsland Water and Goulburn Valley Water. The Grand Final was conducted over Thursday lunch and each of the samples from the finalists were tasted and judged by a panel of four, including technical water experts and industry connoisseurs.

Goulburn Valley Water was announced as the winner at the Thursday evening Awards dinner. Goulburn Valley Water arranged for a water sample to be taken from one of their southern catchment areas as they thought it would be a good chance in this years' taste test competition. The winning sample was taken from the new \$5 million microfiltration Marysville Water Treatment Plant that services the towns of Marysville and Buxton with the capacity to produce up to 2 ML of drinking water per day.

Queensland v NSW Water of Origin Taste Test

For the third consecutive year, the Ixom Water of Origin Taste Test was conducted at the WIOA Queensland Water Operations Conference. The best tasting water from Queensland was pitted against the best tasting water from NSW with conference attendees doing a blind tasting of both samples and voting for their preferred sample. The winner this year was the Queensland sample, supplied from Richmond Shire Council which came up trumps over NSW represented by the Orange City Council. The win put the Queenslanders in the lead 2 to 1 over NSW.

The Queensland sample from Richmond Shire Council came from their brand new water treatment plant that was commissioned in December 2014. Council secured funding of \$3.6 million from the State Government to assist in development and installation of a first class water treatment plant and engaged Aeramix to design and upgrade the plant.

Australia's Best Tasting Tap Water

In a new competition instigated in 2015, the winners from each of the State based Taste Test competitions were pitted against one another to determine which plant produced the Best Tasting Water In Australia. Each of the entries represented not only their water business but their respective States in the battle for bragging rights and national honours.

As part of a WIOA water interest day in Gunnedah NSW, both the interest day attendees as well as Gunnedah residents were given the opportunity to taste and judge the samples from Orange in NSW, Richmond in Queensland, Adelaide in South Australia and Marysville in Victoria.

Goulburn Valley Water's Marysville Water Treatment Plant in Victoria came out on top and was announced as the winner of the Ixom 2015 Australian Water Taste Test and can lay claim to producing the best tap water in Australia for 2015!

The Marysville Water Treatment Plant went through the Black Saturday bushfires and GVW has since rebuilt the facility. Raw water for the Marysville Water Treatment Plant is drawn from the Steavenson River into the off-stream Aub Cuzens Reservoir before being treated using a microfiltration process.

WIOA maintains a strong advocacy role on issues relating to the operational side of the water industry. In particular, we take an active approach in promoting industry awareness and understanding of water quality issues as they relate to public health.

WIOA participates on state and national committees, presents at conferences, seminars and workshops, and supports and informs research and policy development. Standards Australia Sludge Committee

WIOA Director, Peter Tolsher from North East Water in Victoria continued to represent WIOA on the Australian Standards Committee for Sludge recovery, recycling, treatment and disposal.

Australia hosted the International meeting at the Australian Standards office in Sydney in November 2015. This Committee aims to be able to identify the range of Australian interests in ISO developed standards; formulate the Australian position; articulate that position in the appropriate forums; and determine if, to what extent future international standards should be applied in the Australian context.

The Technical Committee consists of a number of organisations that represent various interest groups across the industries.

WIOA will provide periodic reports to members and will seek input from members from time to time to ensure we can appropriately represent everyone's views.

Submission to NHMRC on their future research priorities

In November, the National Health and Research Council released a discussion paper seeking industry feedback on the Draft Water Quality Advisory Committee (WQAC) Work Plan and Proposed Priorities for 2015-2018.

The WQAC draft Work Plan had already identified and suggested a priority level for a number of potential topics or issues. In the WIOA submission, we noted that although WIOA does have an interest in many of the topics already noted in the WQAC Work Plan, we believed that there were two extremely important themes from the operational side of the industry that did not appear to be specifically noted in the Plan.

These themes were:


- Encouraging Operator training, and ultimately the endorsement of operator certification
- Guidance on the management of the Distribution system and in particular, in relation to repairs of main breaks and protection of public health during and after that process.

WIOA contributed an extensive submission to the NHMRC and in it we highlighted that the drivers for training in the water industry Australia wide are not consistent and are in urgent need of some attention and direction by the WQAC. Given that the water industry is regulated on a State by State basis, there is a need for some consistency in the approach taken by the jurisdictional regulators to ensure that uniform operator training standards and competency requirements are in place. The introduction and successful implementation of a National Operator Certification Scheme for example, which specifies agreed competency levels, linked to fit for purpose training is long overdue.

WIOA also noted our concerns about the lack of a standardised and logical approach to managing mains breaks, particularly those that require dewatering of a pipe for its repair. There is now a great deal of evidence in international literature of increased microbial risk associated with mains breaks and repairs, and that contamination from undertaking pipe repair activities can, and is, causing illness.

We hope that our submission will trigger some recognition and action to address these issues, along with the others already identified by the WQAC.

Publications



Works Technical Journal

WaterWorks is a biannual journal published in May and November in 2015. It includes operationally focussed articles and is distributed to almost 7,000 water industry employees as an insert in the Australian Water Association's Water Journal. It is estimated the total readership is around 20,000. WaterWorks will be produced under a different arrangement in 2016 following the withdrawal of AWA as publisher.



Operator Newsletter

Operator is WIOA's quarterly publication which includes individual and corporate member news, general interest stories, water industry news and more. Produced in February, May, August and November each year, it is an effective way of keeping the WIOA community in touch with industry developments.



Words

Words is WIOA's monthly electronic newsletter which includes short updates on training, positions vacant and other items of general interest to members relating to the operational side of the water industry.

Practical Guides

WIOA, in conjunction with a number of supporting sponsor organisations, has produced a range of Practical Guides for water treatment covering aspects from the catchment to the tap. The books are available to the entire industry and provide real value for an exceptional resource.



Laurie was Managing Director of Goulburn Valley Water for 28 years and was highly regarded as an innovative industry leader. He championed the annual Biggest Ever Blokes lunch in Shepparton to raise funds for prostate cancer, so it is a fitting tribute to him to hold this event.

Far North Queensland Charity Bowls Day

In conjunction with a water interest day held in Cairns in October sponsored by Aeramix and Cairns Water, 30 water industry professionals battled the warm weather and enjoyed a pleasant afternoon of lawn bowls and networking in a relaxed, friendly environment.

The Thermo Fisher Scientific team captained by Peter Venville, Loui Macri and Tony Bowater was awarded the "FNQ Tradies Cup".

The event was supported by a number of companies, including: Aeramix, Cairns Regional Council, Grundfos Pumps, Water Treatment Services (Townsville), Xylem, Thermo Fischer Scientific, Royce Water Technologies, Bilfinger Water Technologies. A successful water interest day in Launceston incorporated the Ixom 2015 Tasmanian Water Taste Test and a number of very interesting guest speakers including: Olympic Gold medallist Shane Gould, Alister Laidlaw from North East Water, Mark McConnon from TasWater and technical presentations from Ixom and SFI.

The most interesting part of the day was the Taste Test itself where all members and guests where involved in the heats and tasted and voted for the best water from their table. It was interesting to note how much variability in Taste there was at each table.

Spreyton 11th November

A wastewater interest day was held at the Fonterra milk processing facility in Spryton. This was the first event run by the Tasmanian Advisory Committee at a facility external to TasWater. The main topic was trade waste and Greg O'Rourke form Fonterra described the plant processes and all in attendance learnt more about the wide range of products made from milk. The day included an interesting factory tour which included a DAFF plant that is part of the site.

Greg Rook from the trade waste section of TasWater discussed the relationship between TasWater and Fonterra and described how they are working collaboratilvey to effectively manage the trade waste. This was followed by Bill Woods from TasWater who provided a presentation on biosolids and how they are manged across TasWater sites. Bill's presentation included some of the ideas and opportunities that may be implemented at other sites in the future.


Ensuring Safe Drinking Water Seminar

Over 100 attendees from a number of Victorian and Southern NSW water providers joined Victorian Health Department representatives, to listen to case studies presented by Dr Steve Hrudey from his book "Ensuring Safe Drinking Water – Learning from Frontline Experience with Contamination".

WIOA was pleased be able to jointly facilitate this high quality, interesting and engaging session with the support of the Victorian Department of Health and the Victorian Water Industry Association. Attendees were able to learn from the misfortune / mistakes of others and compare the scenarios presented to situations / sites that they are familiar with. The take home messages were presented as a form of 10 Commandments for Safe Drinking Water. All case studies challenged attendees to see how quickly problems could be detected from all parts of their own systems, and how quickly organisations could respond and deal with problems effectively.

WIOA was proud to host such an event and be able to secure the services of such a high profile international speaker. The value of the knowledge imparted by attending these programs cannot be properly quantified, but if sharing this knowledge prevents

a water quality disaster of any magnitude, then it is priceless.



Frequently Asked Questions

How do I join, how much is membership and how can I pay?
